ORDINANCE No. 018 OF 2017

(December 27)

"BY MEANS OF WHICH THE PERMANENT FAMILY COMMISIONER OF SAN ANDRES ISLAND, WITHIN THE STRUCTURE OF THE DEPARTMENTAL SECRETARIAT OF GOVERNMENT, AND OTHER DISPOSITION ARE DICTATED"

THE ASSEMBLY OF THE DEPARTMENT ARCHIPELAGO OF SAN ANDRES, OLD PROVIDENCE, AND KETHLEENA ISLANDS, in exercise of its constitutional and legal faculties, especially those conferred by the article 311 and 313 of numeral 2 of the Political Constitution

ORDERS

ARTICLE 1. The Commissariat of Family will operate permanently hence the Government of the Department Archipelago's headcount will be expanded with two job posts for FAMILY COMMISSIONER, 2 job posts for professionals in Psychology, and 2 job posts for professionals in Social Work.

PARAGRAPH: Be given faculties to the Governor of the Department Archipelago to manage all related to the implementation, logistics and structure of the New Commissariat of Family. The Governor will determine the time for the provision of jobs and assign the work schedule for each interdisciplinary team, according to the needs of the island.

ARTICLE 2. The Commissariat of Family, according to the latter article, will have, additional to the existent, 2 interdisciplinary work teams; each one will be comprised of a lawyer that will be Family Commissioner, 1 psychologist, and 1 social worker.

ARTICLE 3. To guarantee the integral protection of the communities they tend to, it will count on the permanent collaboration of the programs in charge of law enforcement and social well-being of the population resident on the island of San Andres.

ARTICLE 4. BUDGET AND FINANCING. The Governor and the Assembly will decide on the assigning, reorganizing and redistribution of budgetary, financial, physical and human resources to comply with the hereby ordinance.

ARTICLE 5. QUALITIES. The Family Commissioner must meet the requirements established in the Article 80 and Article 85 of the Childhood and Adolescence Code, Law 1098 of 2006, or regulations that reform or complement it.

ARTICLE 6. VALIDITY. The ordinance hereby goes into effect from the moment it is sanctioned and published.
